IMPORTANT RESERVATION INFORMATION

1. A Cub World Session consists of four days, three nights.
2. Space reservations (initial \$100.00 deposit) are non-refundable and non-transferable, but will be applied to your Pack's total camp fees.
3. A \$25.00 per week or single session camper deposit is due by **MARCH 31st**. This camper deposit is required for the total number of youth your Pack is projecting to attend Cub World (**Camper Deposit Example: Pack #2 is projecting 5 youth and 4 adults for session 1A & 1B. Therefore, 5 youth @ \$25.00 (camper deposit) = \$125.00 due by March 31st.**)
4. **SAVE MONEY BY MAY 31st**. If you pay your camper fees by MAY 31st you will save \$15.00 per session/per camper. The original \$100 space deposit is not used towards qualifying for the EARLY BIRD DISCOUNT but will be credited to your pack's payments upon check-in.
5. The Leadership policy of the Boy Scouts of America requires each unit to have a minimum of two (2) adult leaders in camp at all times, one of whom must be 21 years of age or older and trained. Packs that cannot provide the required adult leadership should contact their District Executive Staff to discuss the potential of teaming up with another Pack from your District or Borough to meet standards for leadership policy. All Tiger Cubs must attend with an adult partner and must be at least six (6) years of age.
6. Only registered Tigers, Cub Scouts, or Webelos can attend Cub World.
7. The participation of Den Chiefs is acceptable as additional leadership (in addition to the minimum requirements as outlined in number 5 above). A "Den Chief" is a currently registered Boy Scout (at least First Class in rank) who has been approved by the Cubmaster and/or the Pack Committee. The Den Chief ratio is 1:8 (one to eight) and a Pack may not exceed this ratio. All Den Chiefs will pay the "Additional Leader Fee."
8. Sorry, siblings of Cub Scouts who are not registered members of the Boy Scouts of America are not permitted to attend Cub World.
9. All adults and Scouts attending Cub World must bring an official completed medical form signed and stamped by their personal physician. Medical Forms must have all requested information filled in. All medical examinations must be within the past twelve (12) months.
10. Early arrival or late departure will be arranged only if absolutely necessary (e.g. religious purposes) and may require additional fees.
11. To accommodate everyone, reservations are on a first-come, first-served basis with completed applications and fees.
12. If you do not hear from Camping Services within two weeks of making a reservation, please call us at (212) 651-2955 to confirm your reservation has been received and approved. You may also E-mail us at Camping@bsa-gnyc.org
13. It is highly recommended that leaders make photocopies of this form as well as any other applications and receipts of payments for your own records.
